**A. BRENT TSUDA WITH SHOOTER DETECTION SYTEM**

Brent discussed the benefits of Shooter Detection System (SDS) and the authority in gunshot detection technology. The SDS sensor detects gunfire in a field of view, no line of sight required. It allows for real-time alerting in under once second automation and communication. The software pinpoints shot location on floor plan map.

Santa Barbara County Education Office abstained from voting; Blochman Union School District, Santa Maria Joint Union School District, and Santa Ynez Valley Union High School District voted “no.”

- Lompoc Unified School District (4 of 4): Approved with the contingency of only reimbursing 50% of initial requested amount.

Motion made by Sean Chenoweth, Santa Maria-Bonita School District, seconded by Leopoldo Amador, Santa Ynez Valley Union High School District, to approve the Safety Incentive Fund request from Lompoc Unified School District in the amount of \$3,733.54. Motion passed unanimously via roll call vote of all voting members present, with representatives from: Blochman Union School District, Goleta Union School District, Lompoc Unified School District, Santa Barbara County Education Office, Santa Maria-Bonita School District, and Santa Ynez Valley Union High School District voting “aye.” Buellton Union School District, Hope School District, Santa Maria Joint Union School District, and Vista Del Mar Union School District were not present.

- Hope School District: Approved

Motion made by Jesse Duncan, Hope School District, seconded by Leopoldo Amador, Santa Ynez Valley Union High School District to approve the Safety Incentive Fund request from Hope School District as requested, in the amount of \$2,144.71. Motion passed via roll call vote of all voting members present, with representatives from: Blochman Union School District, Goleta Union School District, Hope School District, Lompoc Unified School District, Santa Maria-Bonita School District, and Santa Ynez Valley Union High School District voting “aye.” Buellton Union School District, Santa Maria Joint Union School District, and Vista Del Mar Union School District were not present; Santa Barbara County Education Office voted “no.”

Motion passed unanimously via roll call vote of all voting members present, with representatives from: Blochman Union School District, Goleta Union School District, Hope School District, Lompoc Unified School District, Santa Barbara County Education Office, Santa Maria-Bonita School District, and Santa Ynez Valley Union High School District voting “aye.” Buellton Union School District, Santa Maria Joint Union School District, and Vista Del Mar Union School District were not present.
